## THE MEGA 360 Event Game Conditions

## RULES AND REGULATIONS:

1. "THE MEGA 360 Event" (the "Final Event") is governed by the Rules and Regulations Respecting Lotteries and Gaming (The "General Rules") of ATLANTIC LOTTERY CORPORATION (ALC) WHICH INCLUDE LIMITATIONS OF LIABILITY AND ARE AVAILABLE FROM ALC UPON REQUEST and these Game Conditions.
2. These Game Conditions (hereinafter referred to as the "Rules") apply to the Final Event (s) related to all \$5 "THE MEGA 360" instant ticket game(s) and "THE MEGA 360" Instant Win game that are conducted and managed by ALC. Unless otherwise noted, these Rules operate as separate and distinct from any conditions contained on any "THE MEGA 360" Instant tickets and "THE MEGA 360" Instant Win Game.
3. Words used in these Rules which are used in the General Rules shall have the same meaning as those used in the General Rules. In the event of any conflict or inconsistency between these Rules and the General Rules, the General Rules shall govern.

## ANIMATED WHEEL AT RETAIL LOCATION:

4. In the event of any discrepancy or dispute between (i) the prize displayed on the animated wheel at a retail location for a Mega 360 ticket and (ii) the prize, if any, recorded on ALC's Central System for the control/validation number for that Mega 360 ticket, the information on ALC's Central System for the control/validation number for that Mega 360 ticket will prevail and will be the final authority in determining the prize the player is entitled to claim.

## ELIGIBILITY TO PARTICIPATE

5. In order to participate in the Final Event and/or be eligible to receive all or part of a Prize (as herein defined in Rule 12) (personally or as a member of a group as applicable), a player must:
(a) meet all applicable eligibility requirements as contained in the General Rules
(b) be the holder lawfully entitled to possession of a winning \$5 "THE MEGA 360" instant ticket and/or Instant Win game that qualifies such holder to participate in the Final Event pursuant to the play instructions for such ticket;
(c) prior to participating in the Final Event, have participated in good faith in any investigation conducted by ALC and satisfied ALC that they are the holder lawfully entitled to possession of the $\$ 5$ "THE MEGA 360" Instant ticket and/or Instant Win game and are entitled, and will remain entitled, to any Prize;
(d) have initiated the prize claim prior to the expiry date for prize claims for the relevant \$5 "THE MEGA 360" Instant ticket referenced in Rule 4(a); and
(e) have otherwise complied with the General Rules in all other respects.
(f) must be 19 years of age or older.

## FINAL EVENT PARTICIPATION

6. A player may participate in the Final Event in one of three (3) ways, as outlined in Rules 6 to 8.
7. Spin- Subject to Rules 7 and 8 a player may elect to participate using the Spin method. When participating using this method:
(a) a player will be provided three (3) chances to complete a single valid Spin. A valid Spin consists of at least three (3) full three-hundred and sixty degree ( $360^{\circ}$ ) rotations of The Mega 360 Wheel (the "Wheel") in a downward direction, as determined by ALC. After the player has completed their first valid Spin, he/she will not be provided any more chances to Spin. Any Spin that is not a valid Spin is deemed to be void and shall not result in any entitlement to a Prize;
(b) the start position of the Wheel for a Spin will be determined by an electronic RNG draw. ALC will conduct an electronic draw using its certified Electronic RNG draw equipment prior to the Spin Event. The draw parameters will be set to draw 1 number at random from among all numbers from 1 to 20 to determine the start position of the Wheel for each Spin in accordance with Rule 14. The number drawn will signify the starting sector position of the wheel for the Spin attempt. The second and third attempts if necessary will start from the resting place of the invalid spin. The Wheel has sector numbers clearly labeled from 1 to 20 (e.g. if the first number drawn is 4 then the starting position of the Wheel for the first Spin attempt would be sector 4 );
(c) the Prize to which the player is entitled shall be determined by the final resting place of the Wheel at the end of the first valid Spin. The Wheel is deemed to have reached the final resting place when it comes to a complete stop and ALC declares the Spin complete. The Prize will be determined by the final resting place of the white plastic tab that produces the "click" noise. For avoidance of doubt, the white plastic tab shall ultimately determine the Prize and not the red arrow. If for any reason the Wheel moves after ALC has declared the Spin complete, the position of the Wheel at the time ALC declared the Spin to be complete shall be deemed as the final resting place of the Wheel; and
(d) in the event a player does not complete a valid Spin after three (3) attempts, the electronic (RNG) Draw method shall be used to determine a player's entitlement to a Prize.
8. Electronic RNG Draw - to participate using this method:
(a) if a player is unable to participate using the Spin method for reasons of disability or infirmity he/she may elect to have his/her final Prize determined by an electronic draw with the certified RNG, or a player may be required to proceed with the electronic draw with the certified RNG pursuant to Rule 6(d), or a Group may elect to proceed with an electronic draw with the certified RNG accordance with Rule 11;
(b) the Corporation will conduct one (1) random draw from all numbers 1-20 using an electronic draw with the certified RNG to determine the player's entitlement to a Prize; and .
(c) the first number drawn from the electronic draw with the certified RNG shall determine a player's entitlement to a Prize in accordance with the table in Rule 14.
9. Default Win- If:
(a) a player is unable or unwilling to designate a Proxy, within the time specified by ALC for doing so;
(b) a player is unable or unwilling to attend the Final Event at the location and time specified by ALC, or prior to the expiration date of a winning ticket;
(c) a Group has elected to participate by means of a Default Win;
(d) a Group fails to make an election under Rule 11 within the time specified by ALC for doing so; and/or

ALC shall award the lowest Prize denomination as outlined in Rule 12 and there shall be no right to any other Prize with respect to the Final Event.
10. Proxy-Subject to ALC's approval, if a player or Group Designate is unable to participate using the Spin method for reasons of disability or infirmity, or if he/she is unable or unwilling to attend the Spin or electronic (RNG) Draw event at the location and time specified by ALC, the player or the Group may make a written election to have a Proxy to act on his/her/their behalf. A Proxy:
(a) shall have no entitlement to any Prize resulting from the Final Event and may be required to execute a release indicating the same prior to participation in the Final Event;
(b) will participate in a Spin or electronic (RNG); Draw in the place of the designator(s), and the result of such Spin shall be final and binding on the designator(s) of the Proxy; and
the Proxy may not exercise the election to participate through the electronic (RNG) method, and such election may only be made by the designator. A Proxy must be 19 years of age or older, and must not be an employee of ALC.
11. The electronic (RNG) Draw and/or Spin(s) will take place at a location, date and time designated by ALC. Subject to Rule 9, in order to participate through the electronic (RNG) Draw or Spin method, the player or Proxy must attend.

## GROUP PLAY

12. If the holder lawfully entitled to possession of a "THE MEGA 360 " Instant ticket that meets the requirement contained in Rule 4 is more than one individual (a "Group"), the members of the Group shall either:
(a) select a single representative to participate in a Spin or electronic (RNG) Draw (a "Designate"). or
(b) elect to participate through a Default Win; and
each member of the Group is deemed to represent and warrant to ALC that there are no additional members of the Group that may make a claim to entitlement to a Prize and all
members of the Group must, prior to participating in the Final Event, execute a release confirming the selection of a Designate and/or their election and that the result of such Designate's Spin or electronic (RNG) Draw or the Default Win shall be final and binding on all members of the Group. Note that "THE MEGA 360" Instant Win game is not permitted to be played, nor can the prizes be redeemed, by a Group.

## PRIZE STRUCTURE AND ODDS OF WINNING

13. The following prizes are available to be won and the odds of winning each prize are as follows (each a "Prize" and collectively "Prizes");

| $\$ 400,000(\mathrm{CAD})$ | 1 in 20 |
| $\$ 500,000(\mathrm{CAD})$ | 1 in 10 |

14. For the avoidance of doubt, the odds of winning refer only to odds of winning each Prize in a Spin or electronic (RNG) Draw of the Final Event, and do not refer to the odds of winning any prize on any "THE MEGA 360" Instant tickets.

## STARTING POSITION FOR THE WHEEL AND ELECTRONIC (RNG) DRAW PRIZES

15. For the purpose of determining the starting position of the Wheel in accordance with Rule 6 and determining entitlement to a Prize using the electronic (RNG) Draw method, the numbers used in the electronic draw and the electronic (RNG) Draw shall correspond to the Wheel Starting Positions/Prize Denominations as follows:

## MISCELLANEOUS

16. If for any reason ALC determines that the electronic RNG draw referenced in Rule 7 or the Wheel has malfunctioned or is likely to malfunction due to a technical failure, ambiguous Spin result, or otherwise, ALC may postpone the completion of an electronic draw or Spin until such time as it determines that the electronic draw mechanism and Wheel have been restored to proper functioning order.
17. Any election by a player or Group as referenced in these Rules shall be in writing in a form prescribed by ALC.
18. Prior to participating in the Final Event by the Spin or electronic (RNG) Draw method the participant must execute a waiver release in favour of ALC in writing in a form prescribed by ALC.
19. ALC may amend these Rules at any time and in any manner.
20. The headings in these Rules are for convenience of reference only and do not affect the interpretation of these Rules.
21. All draws will adhere to the draw procedures established for the draw by ALC.
22. The terms "Proxy", "player", "Group", and "Designate" are interchangeable as context requires.
