Ballot

QR Code

To enter the contest through the QR code, an entrant must be a resident of Newfoundland, New Brunswick, Prince Edward Island, or Nova Scotia, be 19 years old or older, have a verified alc.ca account to sign in to 2Chance.alc.ca/videolottery and either scan the QR code on marketing material within all ALC (ATLANTIC LOTTERY CORPORATION) video lottery site on their mobile device or manually enter the unique number. QUALIFYING GAMES
