

## **OFFICIAL RULES FOR THE PRO•LINE “FALL MULTI-SPORT” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION (ALC)**

The PRO•LINE “Fall Multi-Sport” promotion provides all prolinestadium.com members (not available for purchase at retail locations) an opportunity to receive up to \$350 in free-play tokens (maximum of \$50 per Weekly Promotional Period) from 06:00:00 Atlantic Standard Time (AST) on October 9, 2023, to 23:59:59 AST on November 26, 2023 (“Promotion Period”).

To earn a \$10 token, a single wager equal to or greater than \$20 must be placed on PRO•LINE or STADIUM•BETS during the Promotion Period. Participants can earn up to five (5) \$10 tokens per week during the Promotion Period. A maximum of thirty-five (35) \$10 tokens (total of \$350) can be earned during the seven (7) week Promotion Period. Tokens can be used only on a 2+ event parlay on PRO•LINE or STADIUM•BETS and expires on December 31, 2023.

The Weekly Promotional Period runs as follows:

- a. Monday, October 9 at 06:00:00 to Monday, October 16 at 5:59:59
- b. Monday, October 16 at 06:00:00 to Monday, October 23 at 5:59:59
- c. Monday, October 23 at 06:00:00 to Monday, October 30 at 5:59:59
- d. Monday, October 30 at 06:00:00 to Monday, November 6 at 5:59:59
- e. Monday, November 6 at 06:00:00 to Monday, November 13 at 5:59:59
- f. Monday, November 13 at 06:00:00 to Monday, November 20 at 5:59:59
- g. Monday, November 20 at 06:00:00 to Sunday, November 26 at 23:59:59

This is an online only promotion. To earn a \$10 free-play token, prolinestadium.com members must have an active and funded alc.ca account.

There is a limit of thirty-five (35) tokens of \$10 per account (total of \$350) during this Promotion Period. A maximum of five (5) \$10 tokens can be earned during each Weekly Promotional Period as outlined above. To obtain the maximum number of \$10 free-play tokens for the Promotion Period, a player must make five (5) separate eligible wagers each equal to or greater than \$20 during each of the seven (7) Weekly Promotional Periods during the Promotion Period.

**\*Each \$10 token can be used only on PRO•LINE or STADIUM•BETS which involves a 2+ event parlay, at prolinestadium.com only (cannot be used at retailer locations). Tokens earned must be used by December 31, 2023, at 23:59:59. It is important to note that the entire \$10 token must be used on one wager. The balance left from any wager made that is less than \$10 will be lost. Token amount will be deducted from winnings.**

### **Promotion Period:**

The offer begins at 06:00:00 Atlantic Standard Time (AST) on October 9, 2023 to 23:59:59 AST on November 26, 2023.

## **HOW TO PARTICIPATE:**

To participate in this promotion:

1. Spend an amount of \$20 or more on PRO•LINE or STADIUM•BETS at prolinestadium.com during the Promotion Period and receive a \$10 token (maximum of thirty-five (35) tokens during the Promotion Period) that can be used on a 2+ event parlay on PRO•LINE or STADIUM•BETS.
2. This promotion can be used up to five (5) times per week, in accordance with the Weekly Promotional Period, to earn a total of thirty-five (35) \$10 tokens (maximum of \$350). Note: A maximum of one (1) \$10 free-play token will be awarded for each single eligible PRO•LINE or STADIUM•BETS wager totalling \$20 or more during one (1) transaction, so that a single wager on one (1) ticket of, for example, \$30 or \$45 will generate one (1) \$10 free-play token.
3. To participate in the promotion: participants must be 19+; must be a resident of Atlantic Canada; and must have an active and funded alc.ca online account.
4. The offer will run from 06:00:00 Atlantic Standard Time (AST) on October 9, 2023, and closes at 23:59:59 AST on November 26, 2023.

## **PROMOTION REWARDS:**

1. Eligible participants will receive up to a maximum of thirty-five (35) \$10 free-play tokens (maximum of five (5) \$10 tokens per week in accordance with the Weekly Promotion Period) for eligible wagers placed on PRO•LINE or STADIUM•BETS during the Promotion Period.
2. The \$10 free-play tokens will be automatically added to accounts that have made qualifying wagers.
3. Tokens earned can only be used on PRO•LINE or STADIUM•BETS wager which involves a 2+ event parlay.
4. Only one token may be used on a single game. A single game includes the sum of all betting markets for that game. For example, you cannot use a token on the moneyline, and then use a second token on the same moneyline, the Spread, Total, H2H (head-to-head) or Winning Margins markets for the same game.
5. Eligible participants must use their \$10 free-play token by December 31, 2023 at 23:59:59 AST (token has no cash value otherwise).
6. There is no cash option for this offer. Token(s) hold no cash value and cannot be used towards earning another token(s).
7. Token amount will be deducted from winnings.

10. Participants must have an active alc.ca account in order to claim their \$10 free-play token(s).

Please note: Any individual who has falsified their registration information will be ineligible to receive their \$10 token(s).

## **DELIVERY OF PRIZES**

The \$10 free-play token(s) will be automatically added to accounts that have made qualifying wagers. These can be found under "Free Bet Tokens" on the Check-Out page when placing your eligible wager.
