for Atlantic Lottery's / de Loto Atlantique

PROMOTIONAL OFFER:

The Contest Period starts on November 15, 2021 9:00 AM AST and ends on January 9, 2022 11:59:59 PM AST. To enter this contest, an entrant must have a verified alc.ca account, however an account is not necessary for the voting purposes. For every vote placed while signed into their alc.ca account, players will earn one (1) entry into the grand prize draw and the applicable weekly draw. Players will also have the opportunity to earn one (1) Bonus Spin to multiply their grand prize entries and weekly draw entries directly after their vote has been made. Entries will be awarded as per the table below:

1 vote	1 Entry
Bonus Spin: Purple	1 additional entry
Bonus Spin: Red	2 additional entries
Bonus Spin: Green	3 additional entries
Bonus Spin: Blue	4 additional entries
Bonus Spin: Orange	5, 6, or 10 additional entries

Participants will have the option to vote on an online landing page for their favourite of the six competing games to bring back. Every two weeks during the Contest Period, one (1) game with the least amount of votes will drop off until we are left with 3 games. The game that has the most votes in the final two weeks will be selected as the winning game. The games to vote on are the following:

Grand Prizing:

Weekly Prizes:

DRAWS AND PRIZES

Weekly random draws: all eligible Retro Contest entries for each week will be entered into a draw to win one (1) \$1,000 prize for each of the eight (8) weeks during the Contest Period. Entrants may win more than one weekly prize during the contest if entered in subsequent weeks, however, entrants can only win once during each weekly draw. Weekly prize winners will be eligible to win one of the grand prizes. NOTE: Each weekly draw will be made from entries received for that weekly draw only; entries from 1 weekly draw do not participate in subsequent weekly draws.

Contest period (“Grand Prize”): 9:00:00 a.m. AST on November 15, 2021 and closes at 11:59:59 p.m. AST January 9, 2022. The draw will take place on January 11, 2022, or as soon as possible thereafter. Entrants are eligible to win both the grand prize and a weekly cash prize. Each Grand Prize Draw will be made from all valid entries received in each of the 3 territories below during the Contest Period.

Grand prize:

NO PURCHASE ENTRY

No purchase is necessary to participate; however, an entrant must have a verified alc.ca account to earn valid entries into the contest.

ENTRY LIMIT

There is a limit of one (1) vote per person per alc.ca account per day to earn entries (each day runs from 12:00:00am to 11:59:59pm AT with the exception of November 15, 2021 where the day begins at 9:00:00am AT). For greater certainty and the avoidance of any doubt, you can only use one (1) account to enter the contest. ODDS OF WINNING

The odds of winning a weekly prize will depend upon the total number of eligible entries received from all 4 provinces for that weekly draw. Entries for each weekly draw are entered for that weekly draw only and are not entered into subsequent weekly draws. The odds of winning the grand prize depends on the total number of eligible entries received during the Contest Period by each of the 3 regions.

DELIVERY OF PRIZES

ALC will attempt to contact the potential winner(s) within one (1) business day after the weekly draws and for the grand prize winners (or as soon as possible thereafter). Potential winners will be notified using the contact information provided in the alc.ca account. If ALC is not able to contact the potential winner within 48 hours after initial attempt, ALC shall have the right to disqualify the potential winner; the entry drawn immediately after the disqualified entry for the prize will be eligible to win the prize that otherwise would have been awarded for the previously select entry. This process will continue until ALC is able to contact a potential winner as referred to in this section.
