

## OFFICIAL TERMS & CONDITIONS FOR THE PRO•LINE “LAPSING PLAYER” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION

The PRO•LINE “Lapsing Player” promotion is sponsored by ALC and provides select prolinestadium.com members with an opportunity to redeem free-play token(s), as outlined in these terms and conditions.

There are two (2) player cohorts used to determine player eligibility and the corresponding offer. The offer are distributed via free-play tokens automatically deposited into the players’ alc.ca account based on the following criteria:

1. **Cohort one:** Alc.ca players who have wagered a cumulative \$1,000 or more on PRO•LINE between January 1 and December 31, 2025, but have made no wagers since January 1, 2026. This player cohort qualifies for \$20 in free-play tokens (2 x \$10 free-play tokens).
2. **Cohort two:** Alc.ca players who have wagered between \$10 and \$1,000 on PRO•LINE between January 1 and December 31, 2025, but have made no wagers since January 1, 2026. This player cohort qualifies for a \$10 free-play token.

### **PROMOTION PERIOD**

The free-play token(s) will be issued on June 17, 2026 at 06:00:00 Atlantic Time and expire on September 30, 2026 at 23:59:59 Atlantic Time (“Promotion Period”).

### **HOW TO PARTICIPATE**

To participate in this promotion:

1. A participant must be opted in to receive promotional offers from alc.ca and be selected by alc.ca to participate in this promotion based on the player cohort criteria outlined in these terms and conditions.
2. Eligible players will have access to PRO•LINE free-play token(s) based on their corresponding cohort. No purchase necessary.
3. Cohort eligibility is based on “cash” wagers. Free-play tokens and promo cash values are not included as part of the total wager amount.
4. Must be nineteen (19) years of age or older and must be a resident of New Brunswick, Nova Scotia, Newfoundland and Labrador, or Prince Edward Island. *Note: Residents of Prince Edward Island are not eligible if they have not wagered or engaged with alc.ca in 12 months or more since the start of this promotion.*
5. The offer will run from June 17, 2026, at 06:00:00 Atlantic Time and closes on August 31, 2026, at 23:59:59 Atlantic Time.
6. Once all criteria are met, the free-play token(s) will be automatically added to the eligible participant’s alc.ca account.

### **PROMOTION REWARDS**

1. Eligible participants will receive PRO•LINE free-play token(s) based on their eligibility and corresponding player cohort. Token(s) will be automatically added to their alc.ca account on June 17, 2026.

2. Token(s) redeemable on PRO•LINE, STADIUM•BETS, FANTASY and FUTURES only. Only one (1) token may be used on a single game. A single game includes the sum of all betting markets for that game. For example, you cannot use a token on the moneyline, and then use a second token on the same moneyline, the Spread, Total, H2H (head-to-head) or Winning Margins markets for the same game.
3. Eligible participants must use their free-play token(s) by September 30, 2026, at 23:59:59 Atlantic Time, after which the token(s) will expire and be void.
4. There is no cash option for this offer. Tokens hold no cash value and cannot be used towards earning another tokens.
5. This promotion is non-transferable and is not available at retail locations.
6. Token amount will be deducted from winnings.
7. Tokens are non-withdrawable.

### **PROMOTION ELIGIBILITY**

This offer is sponsored by ALC and is open to residents of New Brunswick, Nove Scotia, Newfoundland and Labrador, and Prince Edward Island who are nineteen (19) years of age or older, have a verified and valid alc.ca account, are members of prolinestadium.com, and have been selected to participate by ALC based on the cohort criteria outlined in these terms and conditions.

*Note: Residents of Prince Edward Island are not eligible if they have not wagered or engaged with alc.ca in 12 months or more since the start of this promotion. Any individual who has falsified their registration information will be ineligible to receive their free-play tokens.*

The PRO•LINE free play token(s) will be automatically added to eligible accounts. They can be found under “PRO•LINE Tokens” or “Free Bet Tokens” on the checkout page when placing a wager.
