

## **OFFICIAL TERMS & CONDITIONS FOR THE “INSTANT WINS AND CASINO ALC.ca BONUS MARCH 2026” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION (ALC)**

The "Instant Wins and Casino ALC.ca Bonus March 2026" promotion is available to residents of Nova Scotia, New Brunswick, and Newfoundland and Labrador from 00:00:00 Atlantic Time on March 20, 2026, to 23:59:59 Atlantic Time on March 23, 2026. **This promotion is not available to residents of Prince Edward Island.** Participants must have a valid, active and funded alc.ca account.

To earn the \$25 alc.ca bonus, eligible players must deposit a cumulative, total amount of at least \$50 into their alc.ca account and spend a cumulative, total amount of at least \$25 on Instant Wins and/or Casino games (including Live Casino, where offered and available to the player) available on alc.ca during the Promotion Period. Participants can earn a maximum of one (1) \$25 alc.ca bonus during the Promotion Period.

### **PROMOTION PERIOD**

The promotion will take place between 00:00:00 Atlantic Time on March 20, 2026, to 23:59:59 Atlantic Time on March 23, 2026 (“Promotion Period”).

### **HOW TO PARTICIPATE**

To participate in this promotion:

1. Participants must deposit a total, cumulative amount of at least \$50 into their alc.ca account and spend a total, cumulative amount of at least \$25 on Instant Wins and/or Casino games available on alc.ca during the Promotion Period.
2. The \$50 deposit and \$25 spend requirements can be met through multiple, cumulative deposits and spends. Promo cash will not be accepted as a funding option for the deposit and spend requirements.
3. The \$50 deposit criteria can only be met by a player manually adding funds to their alc.ca account. Online lottery subscriptions and lottery winnings automatically deposited into accounts will not be considered deposits for this promotion.
4. Once all criteria are met, the player will have their \$25 alc.ca bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
5. The offer will run from 00:00:00 Atlantic Time on March 20, 2026, to 23:59:59 Atlantic Time on March 23, 2026.

### **PROMOTION RULES**

1. Eligible participants can earn a maximum of one (1) \$25 alc.ca bonus during the Promotion Period.

2. Once all criteria are met, the player will have their \$25 alc.ca bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
3. The \$25 alc.ca bonus can be used for alc.ca purchases only. Not exchangeable for cash or cash equivalents.
4. This Promotion is non-transferrable.
5. Limit of one (1) \$25 alc.ca bonus per alc.ca member/account.
6. Offer is available to residents of New Brunswick, Nova Scotia and Newfoundland and Labrador only.

### **PROMOTION ELIGIBILITY**

This offer is sponsored by ALC and is open to residents of New Brunswick, Newfoundland and Labrador and Nova Scotia, who are nineteen (19) years of age or older, have an active and funded alc.ca account, and reside in Atlantic Canada at the time of entry. This promotion is not available to residents of Prince Edward Island.

*Note: Any individual who has falsified their registration information will be ineligible to receive their \$25 alc.ca Bonus.*

### **DELIVERY OF PRIZES**

Once all criteria are met, the player will have their \$25 alc.ca bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.

1. alc.ca members who have registered through fraudulent means or have provided false or misleading information will be disqualified. ALC will not be responsible for failed entry attempts for any reason whatsoever.
