

OFFICIAL CONTEST RULES AND TERMS AND CONDITIONS FOR THE “VIDEO LOTTERY MONTHLY” CONTEST FROM THE ATLANTIC LOTTERY CORPORATION

The “Video Lottery Monthly” contest is sponsored by Atlantic Lottery Corporation Inc. (“ALC”) and is open to residents of New Brunswick, Prince Edward Island, and Newfoundland and Labrador from 00:00:00 Atlantic Time (“AT”) on April 1, 2026 to 23:59:59 AT on March 31, 2027. Participants must have a valid and active alc.ca account.

Please Note: The Video Lottery Monthly contest is not offered in Nova Scotia and residents of Nova Scotia are not eligible to enter this contest.

The contest provides participants with a chance to win monthly cash prizes, eGift cards, and promo cash (values and denominations can be found in the “Draws and Prizes” section of these Terms and Conditions). To earn entries into the contest, participants must enter a contest ballot, which is earned by completing a bonus round when playing eligible Video Lottery games (specified in the “Eligible Games” section of the Terms and Conditions) during the Contest Period.

CONTEST PERIOD

The “Video Lottery Monthly” contest will take place between 00:00:00 Atlantic Time April 1, 2026 and 23:59:59 AT on March 31, 2027 (“Contest Period”).

HOW TO PARTICIPATE

How to participate in this contest:

1. To enter the draw for a chance to win, a participant must play an Eligible Game (specified below), complete the bonus round and either scan the Video Lottery Terminal (“VLT”) ballot barcode on a mobile device or manually enter the unique VLT ballot number into the Video Lottery contest site during the Contest Period.
2. To participate in the contest, participants must be 19+; must be a resident of New Brunswick, Prince Edward Island, or Newfoundland and Labrador; and must have an active alc.ca online account.
3. Participants can enter a maximum of five (5) VLT ballots per day during the Contest Period. For each VLT ballot entered at promotions.alc.ca/videolottery, this will earn the participant five (5) monthly contest entries and earn one (1) spin on 1 of 3 contest reel games on promotions.alc.ca/videolottery (“Contest Website”). For the chance to earn additional entries into the monthly contest draw or to win promo cash or eGift cards, the participant is required to play the online contest reel game, located on the Contest Website.
4. Potential winners of the monthly cash draw will have seven (7) days to provide their information once an ALC representative has contacted them via email.
5. Potential winners of eGift cards will have to complete an online prize claim form by 23:59:59 AT on April 2, 2027.
6. No purchase is necessary to enter this contest. See below for details.

Eligible Games

Eligible Games will be indicated on the Video Lottery Terminals (VLT's) with the inclusion of the Atlantic Lottery logo over the game icon. Any player that receives a ballot during their Video Lottery play must follow the directions outlined on the ballot. The Eligible Games include:

ALC has the right to launch new Eligible Games or remove any Eligible Games at any point during the Contest Period.

DRAWS AND PRIZES

1. During the Contest Period, participants have a chance to win monthly cash prizes, eGift cards, and promo cash.
2. Prizing is non-transferable.
3. If the potential winner of the monthly cash draw has not contacted ALC within seven (7) days of being notified of the winning, ALC shall have the right to disqualify the potential winner and draw an alternate winner for the same prize. ALC shall be fully and completely released and discharged from any liability or responsibility in this regard. Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of nineteen (19) they will be disqualified and an alternate winner for the same prize will be drawn.

Monthly Draw Prizing

All eligible Video Lottery contest entries received during the Monthly Contest Period will be entered into a draw to win one (1) of five (5) monthly cash prizes of \$1,000. Entrants may be eligible to win multiple monthly cash prizes during the Contest Period, provided they enter in different months; however, only one prize may be awarded per entrant per monthly draw.

Online Reel Game Prizing

This contest offers the chance to win additional entries, promo cash prizes and eGift cards each month by playing the online contest reel game, located on the Contest Website.

Prizes awarded through the online contest reel games will be awarded as per the table below, and prize generation will end 23:59:59 AT on March 31, 2027.

Players can only win one (1) \$10 promo cash voucher OR one (1) eGift card per spin. Available eGift cards, values and quantities are shown below.

The promo cash codes are valid (available to be redeemed) by the expiration date of 23:59:59 AT on April 2, 2027. If entering the code to redeem after the expiration date, a player will receive an error message stating the promo code is expired.

RANDOM DRAW AND ODDS

On the fourth day of each month (May through April) – or as soon as possible thereafter – a random draw will be conducted for the monthly cash prizes from all eligible entries received during the Monthly Contest Period. The odds of winning the prize will depend upon the total number of eligible entries received during the Monthly Contest Period. All draws adhere to the draw procedures established for the draw by Atlantic Lottery.

Monthly Draws: The monthly draws will take place on the fourth day of the following month, or as soon as possible thereafter. All ballots must be submitted no later than 23:59:59 AT on the last day of each month to be eligible for the monthly draw. Any ballots received after 23:59:59 AT on the last day of the month will be entered into the following month’s draw. Participants are not eligible to win more than one (1) monthly draw prize per month, or more than one (1) prize per spin.

CONTEST ELIGIBILITY

This contest is open to residents of New Brunswick, Prince Edward Island, or Newfoundland and Labrador, who are nineteen (19) years of age or older and reside in one of these provinces.

Notwithstanding the foregoing, this contest is not open to employees (including full-time, part-time and student employees; persons who are directly on payroll; and employees who are on paid or unpaid leave), officers, directors, representatives or agents (and those with whom any of the foregoing persons are domiciled, whether related or not) of the following persons or entities:

2. ALC Video Lottery retailers;
3. New Brunswick Lotteries and Gaming Corporation, New Brunswick Gaming Control and Licensing Services, Nova Scotia Gaming Corporation, Nova Scotia Alcohol, Gaming, Fuel and Tobacco Division, Prince Edward Island Lotteries Commission, or a shareholder of the ALC that is directly involved with the affairs of the ALC;
4. the respective parent companies, subsidiaries, affiliates, prize suppliers, advertising/promotion agencies of any of the foregoing parties mentioned in sections 1 and 2 above; or
5. any entity involved in the development, production, implementation, administration, judging or fulfillment of this Contest.

Note: Any individual who has falsified their registration information will be ineligible to receive their prize upon winning.

NO PURCHASE NECESSARY

No purchase is necessary to enter. Eligible entrants can obtain a no purchase entry (“No Purchase Entry”) by sending a request in writing, including: (a) the entrant’s first and last name, age, and valid email address associated to the entrant’s alc.ca account; (b) a 200-word unique essay describing why they would want to win a prize by mailing the request (in an envelope with sufficient Canadian postage) to: Atlantic Lottery Corporation – Video Lottery Monthly Contest, P.O. with sufficient postage. No Purchase Entry Requests that do not indicate a valid email address associated with an alc.ca account will be ineligible to receive a No Purchase Entry. Unique essays that are produced by mechanical or electronic means and/or that are not reasonable, unique, and original are void. No Purchase Entries must be received by ALC no later than the end of the Contest Period. ALC is not responsible for delayed or no delivery of a No Purchase Entry Request. Players can earn a maximum of five (5) No Purchase Entries per day during the Contest Period. Players must have an active alc.ca member account created prior to sending the No Purchase Entry Request.

In the event of a labour dispute/strike during the Contest Period impacting mail delivery, please contact ALC at 1-800-531-3942 for alternative delivery method.

DELIVERY OF MONTHLY CASH PRIZES

1. ALC will attempt to contact the potential winner within one (1) business day after the draw (or as soon as possible thereafter). If ALC is not able to contact the potential winner after seven (7) days after the initial attempt, ALC shall have the right to disqualify the potential winner, and the entry drawn immediately after the disqualified entry for the prize will be eligible to win the prize that otherwise would have been awarded for the previously selected entry.
2. Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of nineteen (19) they will be disqualified, and the next potential winner will be contacted. Winners will be notified by phone or email.
3. Winner must provide the completed release form issued by ALC, proof of identification and Payment Option Form in person or via email within seven (7) days of being contacted; failure to do this will result in the winner waiving their right to the prize. The release form and prize form must be completed before any prize is issued by ALC.

DELIVERY OF EGIFF CARD PRIZES

Upon winning an eGift card prize on the online contest reel game, participants must click on the prize claim link to access and complete a prize claim form. Participants are responsible for ensuring the accuracy of their account information on alc.ca.

Eligible winners will also see a notification on the Video Lottery contest page prompting them to complete their prize claim form. Participants must be signed into the contest page to view this notification.

Eligible eGift card winners have until April 2, 2027, at 23:59:59 AT to complete and correctly answer, unaided, a mathematical skill-testing question and submit the prize claim form within the time frame indicated. Failure to answer the skill-testing question correctly or submit the form within this timeframe will result in disqualification and the prize will be forfeited. Eligible eGift card winners who successfully complete their prize claim form will instantly receive an email from promotionsgroup@mail.alc.ca with the details of their eGift card prize to the email address associated with their alc.ca account.

Atlantic Lottery is not responsible for lost, stolen eGift card codes as a result of the participants not correctly verifying and or updating their email address.

Players will also be able to locate their eGift card details in their promotions.alc.ca history.

NO REPRESENTATIONS

ALC makes no representations of any kind whatsoever about the computer system used to conduct this promotion and shall not be liable for any loss or damage suffered by any person as a result of the operation of the computer system or the failure of the computer system to operate properly or at all.
