

## **OFFICIAL CONTEST RULES AND TERMS AND CONDITIONS FOR THE “VIDEO LOTTERY CASH QUEST” CONTEST FROM THE ATLANTIC LOTTERY CORPORATION**

The “Video Lottery Cash Quest” contest is sponsored by Atlantic Lottery Corporation Inc. (“ALC”) and is open to residents of New Brunswick, Prince Edward Island, and Newfoundland and Labrador from 10:00:00 Atlantic Time (“AT”) on February 2, 2026 to 23:59:59 AT on March 15, 2026. Participants must have a valid and active alc.ca account.

*Please Note: The Video Lottery Cash Quest contest is not offered in Nova Scotia and residents of Nova Scotia are not eligible to enter this contest.*

The contest provides participants with a chance to win weekly escalating cash prizes, as well as a chance to win the contest grand prize (breakdown can be found in the “Draws and Prizes” section of these Terms and Conditions). To earn entries into the contest, participants must enter an eligible ballot, which is earned by completing a bonus round when playing the eligible Video Lottery games – “Samurai 888 Katsumi” or “Red Hot 7s Wild” – during the Contest Period.

### **CONTEST PERIOD**

The “Video Lottery Cash Quest” contest will take place between 10:00:00 AT February 2, 2026 and 23:59:59 AT on March 15, 2026 (“Contest Period”).

### **HOW TO PARTICIPATE**

How to participate in this contest:

1. To enter the draw for a chance to win, a participant must play an Eligible Game (specified below), complete the bonus round and either scan the Video Lottery Terminal (“VLT”) ballot barcode on a mobile device or manually enter the unique VLT ballot number into [promotions.alc.ca/videolottery](https://promotions.alc.ca/videolottery) during the Contest Period.
2. To participate in the contest, participants must be 19+; must be a resident of New Brunswick, Prince Edward Island, or Newfoundland and Labrador; and must have an active alc.ca online account.
4. Participants can enter a maximum of five (5) VLT ballots per day during the Contest Period. For each ballot entered at [promotions.alc.ca/videolottery](https://promotions.alc.ca/videolottery), this will earn the participant one (1) entry in the weekly cash draw occurring that same week the ballot was entered, as well as earning one (1) grand prize draw entry. Participants can earn a maximum of five (5) entries per day into the weekly draws, and five (5) grand prize draw entries per day.
  - a. Players have a chance to win any weekly cash draw entered plus the grand prize draw.
  - b. Weekly cash draw entries do not carry over week to week.
  - c. Players continue to earn their regular “Video Lottery Monthly Contest” spins for each eligible ballot entered.
5. Potential winners of the cash draw will have seven (7) days to provide their information once an ALC representative has contacted them via email.

### **Eligible Games**

Eligible Games consist of “Samurai 888 Katsumi” and “Red Hot 7s Wild” (the “Eligible Games”).

Any player that receives a ballot during their Video Lottery play from either of the two (2) Eligible Games, must follow the directions outlined on the ballot.

### **DRAWS AND PRIZES**

1. During the Contest Period, participants have a chance to win the weekly cash draw, as well as the grand prize cash draw.
2. Prizing is non-transferable.
3. If the potential winner of the weekly cash draw or grand prize draw has not contacted ALC within seven (7) days of being notified of the winning, ALC shall have the right to disqualify the potential winner and draw an alternate winner for the same prize. ALC shall be fully and completely released and discharged from any liability or responsibility in this regard. Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of nineteen (19) they will be disqualified and an alternate winner for the same prize will be drawn.

### **RANDOM DRAW AND ODDS**

There will be six (6) weekly draws and one (1) grand prize draw for this contest as set out below.

**Weekly Draws:** The weekly draws will take place on the Tuesday of the following week, or as soon as possible thereafter. A random draw will be conducted for the weekly cash prizes from all eligible entries received during the applicable Weekly Contest Period. The odds of winning the prize will depend upon the total number of eligible entries received during each applicable Weekly Contest Period. All draws adhere to the draw procedures established for the draw by Atlantic Lottery.

All ballots must be submitted no later than 23:59:59 AT on the last day of each Weekly Contest Period to be eligible for the weekly draw. Any ballots received after 23:59:59 AT on the last day of the week will be entered into the following weeks draw.

**Grand Prize Draw:** The grand prize draw will take place on March 17, 2026, or as soon as possible thereafter. A random draw will be conducted for the grand prize from all eligible entries received during the Contest Period. The odds of winning the prize will depend upon the total number of eligible entries received during the Contest Period. All draws adhere to the draw procedures established for the draw by Atlantic Lottery.

All ballots must be submitted no later than 23:59:59 AT on March 15, 2026.

### **CONTEST ELIGIBILITY**

This contest is open to residents of New Brunswick, Prince Edward Island, or Newfoundland and Labrador, who are nineteen (19) years of age or older and reside in one of these provinces. Notwithstanding the foregoing, this contest is not open to employees (including full-time, part-time and student employees; persons who are directly on payroll; and employees who are on paid or unpaid leave), officers, directors, representatives or agents (and those with whom any of the foregoing persons are domiciled, whether related or not) of the following entities:

1. ALC;
2. New Brunswick Lotteries and Gaming Corporation, New Brunswick Gaming Control and Licensing Services, Nova Scotia Gaming Corporation, Nova Scotia Alcohol, Gaming, Fuel and Tobacco Division, Prince Edward Island Lotteries Commission, or a shareholder of the ALC that is directly involved with the affairs of the ALC;
3. the respective parent companies, subsidiaries, affiliates, prize suppliers, advertising/promotion agencies of any of the foregoing parties mentioned in sections 1 and 2 above; or
4. any entity involved in the development, production, implementation, administration, judging or fulfillment of this Contest.

*Note: Any individual who has falsified their registration information will be ineligible to receive their prize upon winning.*

### **NO PURCHASE NECESSARY**

No purchase is necessary to enter. Eligible entrants can obtain a no purchase entry ("No Purchase Entry") for the weekly cash draws and the grand prize draw by sending a request in writing, including:

- (a) the entrant's first and last name, age, and valid email address associated to the entrant's alc.ca account; and
- (b) a 200-word unique essay describing why they would want to win the prize.

(collectively, a “No Purchase Entry Request”)

Limit of one (1) No Purchase Entry Request per envelope with sufficient postage. A valid No Purchase Entry request will be entered into the applicable weekly draw and will also be included in the grand prize draw. All No Purchase Entry Requests must be received by ALC no later than 11:59:59 AT on the last day of each Weekly Contest Period to be eligible for that week’s draw. Any ballots received after 11:59:59 AT on the last day of the week will be entered into the following week’s draw.

No Purchase Entry Requests that do not indicate a valid email address associated with an alc.ca account will be ineligible to receive a No Purchase Entry. Unique essays that are produced by mechanical or electronic means and/or that are not reasonable, unique, and original are void. No Purchase Entry Requests must be received by ALC no later than the end of the Contest Period. ALC is not responsible for delayed or no delivery of a No Purchase Entry Request. Players can earn a maximum of five (5) No Purchase Entries per day during the Contest Period. Players must have an active alc.ca member account created prior to sending the No Purchase Entry Request. Any No Purchase Entry Request that does not comply with these Official Contest Rules and Terms and Conditions may be deemed ineligible to earn an entry into the contest at the absolute and unfettered discretion of ALC.

#### **DELIVERY OF PRIZING**

1. ALC will attempt to contact the potential winner within one (1) business day after the draw (or as soon as possible thereafter). If ALC is not able to contact the potential winner after seven (7) days after the initial attempt, ALC shall have the right to disqualify the potential winner, and the entry drawn immediately after the disqualified entry for the prize will be eligible to win the prize that otherwise would have been awarded for the previously selected entry. ALC shall be fully and completely released and discharged from any liability or responsibility in this regard.
2. Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of nineteen (19), they will be disqualified, and the next potential winner will be contacted. Winners will be notified by phone or email.
3. Winner must provide the completed release form issued by ALC, proof of identification and Payment Option Form in person or via email within seven (7) days of being contacted; failure to do this will result in the winner waiving their right to the prize. The release form and prize form must be completed before any prize is issued by ALC.

ALC makes no representations of any kind whatsoever about the computer system used to conduct this promotion and shall not be liable for any loss or damage suffered by any person as a result of the operation of the computer system or the failure of the computer system to operate properly or at all.

3. The chance of winning is dependent on the number of entries received for the contest draw.

By entering this contest, each entrant consents to the collection, use and distribution of his/her personal information (information that identifies an entrant as an individual, such as home telephone number, age and home address) by ALC for the purposes of implementing, administering and fulfilling this contest.
